

The following items or modifications to the original Plans and Specifications shall be included as part of the contract work. All General Conditions, Supplemental General Conditions, or Special Conditions shall remain as originally specified unless otherwise noted herein.

Respective Bidders shall include the provisions of this Addendum in their proposal and shall make a notation in the proposal that these provisions have been included.

GENERAL

- 1) Attached is a list of attendees at the mandatory pre-bid meeting held on November 25, 2025. Any comments, questions or changes discussed in that meeting, that require further clarification to the contract documents are stated herein.
- 2) The Contractor will be responsible for procuring a building permit from the City of Fayetteville Inspections Department. The plans have been submitted by FTCC for permit review and costs for such review has been covered by FTCC.
- 3) Contractor required builder's risk insurance should cover 100% of the amount of the bid.
- 4) The Contractor may use the existing toilet facilities during the entire course of the construction phase. Electric utility costs for power or water (if needed) will be provided by the Owner. All Construction debris shall be hauled off site and legally dumped at the Contractors expense.
- 5) All Contractors wishing to re-inspect the site should first call Rodney Rogers at 910-740-3237 (cell) to schedule an FTCC escort for security purposes.
- 6) There are no alternates proposed for this project. Please leave that area of the bid form blank.

- 2) Sheet TS1.0: General Specifications; Change the Painting Specification to read: (All products noted are by Sherwin Williams. Other similar paint products by PPG or Benjamin Moore will be accepted as equals) For interior gypsum board walls use one prime coat of All Surface Enamel A41 Series Primer and 2 coats of A-200 eggshell acrylic latex paint.
- 3) Sheet A1.0: Door 166D is an existing door relocated from old door opening 162D.
